### **ACC**

- ACC Applications and Issues: No new ACC Applications. Outstanding issues are as follows:
  - o 5284 S. Youngfield Court. ACC application for trash can privacy screen approved by ACC. Approval paper work given to owner and Board
  - 5234 S. Youngfield Court has a very large dead tree in their back yard. The ACC has decided to wait until Spring to better determine what parts of the tree may still be living and address the tree situation then.
  - O Lynda presented to the Board that Republic Trash was no longer picking up plastic bags of tree leaves. Lynda contacted Republic and was told that all leaves had to be in paper bags. The board members were not aware of any formal changes to our contract or policy changes by Republic. ## **New Business and Updates**

- Secretary Updates for GRR/ CO HB22/ Standard Operating Procedures (SOP)/ Records Archive and Retention
  - o BAHOA Sub-committee to meet in November to discuss and implement plan for GRR, CO HB22 implementations into our existing Bylaws and Guidelines, Rules, and Regulations. (*Amended: No meeting has taken place as of January 11*<sup>th</sup>, 2024 HOA Meeting)
  - A timeline for presenting drafts and comments of revisions to HOA members set for end of February 2024. Final versions and a vote to be ready by September Annual Meeting 2024. Timelines to be discussed again at January, 11<sup>th</sup> 2024 Board Meeting
  - O Tim presented a plan for above mentioned updates as well as other policies and procedures that need to be updated or created to be added to existing Bylaws and GRR's. These updates will be reviewed and voted on by HOA members. The plan will be executed using a system called the Big 5. The goal is to make updates to the Bylaws and GRR's as needed, that will make them Simple, Clear, Concise, Effective, and Efficient.
  - Work sessions, actionable items, and requests for assistance will be ongoing during this process.

# • Research and Development of BAHOA Gmail Account to include Google Chat and Google Docs.

- O Lynda presented the Google Chat platform as a way of better communication for the Board. This platform would centralize board communications and keep a record of those communications for historical record.
